## **TERMS AND CONDITIONS**

- Applicants must complete in full the online application for their vending opportunity.
- Submission of application does not guarantee acceptance.

## **VENDOR COSTS**

- Food vendor: \$350 for a vendor booth that moves Saturday morning, \$500 for Bar Area
- A maximum of 6 staff vendor passes per location.
- 1 campsite, Vendor camping to be located at the discretion of the committee.
- Designated Vendor parking for 2 Vehicles
- Electricity not supplied by DSP

## **HOURS OF OPERATION**

- Friday- 4PM TO 1 AM
- Saturday- 1PM TO 1 AM
- Hours of operation subject to revision

## **SUPER PULL POLICIES**

- Event operates rain or shine.
- No sale of products in a glass bottle or container
- Vendors must be set up Friday by 11 AM for inspection.
- All vendors must be 100% operational by Friday a 4 PM
- Vendors are permitted to vend only from their site.
- Festival will provide designated garbage drop areas.
- Festival will provide designated grease disposal.
- It is the responsibility of each vendor to look after their own garbage, recycling, grease and other waste removal from the site.
- Garbage trucks will be located at the South end of Graceland, DSP will not provide any cooking grease disposal.
- Each vendor must remain open for the hours stated.
- General overnight security is provided throughout the festival.
- Vendor space must be fully vacated by 11 AM Sunday June 15, 2025
- Vendor employees must always wear their DSP while onsite.
- Vendor passes are non-refundable and may only be shared amongst incoming and outgoing vendor staff.
- No music may originate from the vendor space.
- Each vendor must provide their own approved fire extinguisher. Inspections by Huron-Kinloss Fire and Emergency Services and Grey Bruce Public health will take place Friday afternoon.
- No smoking cigarettes or marijuana on the DSP grounds
- Vendors are not guaranteed exclusive rights to food items sold.
- Vendors and staff must not consume or be under the influence of alcohol, marijuana or illegal substances while on the festival grounds.

- Vendors may not sell any items with the 'DSP' logo or anyone participating or promoting the pull or demo derby at 'DSP'.
- Photographers and videographers will be onsite to document 'DSP' event. Many of these images will be used in the future for promotional purposes. By attending 'DSP', you are giving up rights you may have with regards to these photos and will be deemed as having given permission for use of the same. This includes, but not limited to, photos, video, and audio. As the attendee you grant 'DSP', its employees, contractors, organizers and all media the right to record, film, tape and photograph for the purposes of promotion and media coverage of the festival. This will include all forms of media including, but not limited to, broadcast, print, email and website usage.
- Failure to comply with rules set forth by DSP will result in the immediate eviction from the premises with no refund.
